

The issue of Human Rights has been at centre stage ever since the Universal Declaration on Human Rights took place in 1948. Many international treaties and conventions have been adopted and brought into force: the International Covenant on Civil and Political Rights (ICCPR); the International Covenant on Economic, Social and Cultural Rights (ICESCR); Convention on the Elimination of All Forms of Discrimination Against Women (CEDAW): Convention on the Elimination of All Forms of Racial Discrimination (CERD); Convention on the Rights of Persons with Disabilities (CRPD): Convention on the Rights of the Child (CRC); United Nations Convention Against Torture (CAT): International Convention on the Protection of the Rights of All Migrant Workers and Members of their Families (ICRMW or more often MWC). Though a lot of progress has been met on the issue but still a lot needs to be done. As we move into the latter half of the second decade of Twenty First Century, an evaluation of the progress made in the path of achieving these rights is called for.
